

DECLARATION OF OWNERSHIP OF TRADEMARK(RENEWAL)

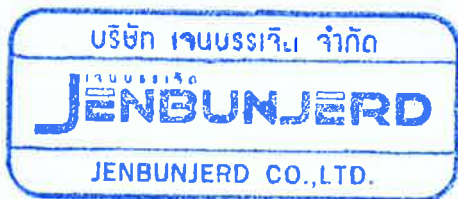


